Game rules (hereinafter referred to as Rules)

1. The Participants and the Organizer

The Rules specify how to arrange the Game and how to participate in the Game. Should the Rules contain unregulated issues, the relevant provisions of the effective law should be applied.

2. Who can participate in the game?

Should the Participant not accept the Rules, they will not be entitled to participate in the Game and will be automatically excluded from the Game.

The employees of the Organizer and their close relatives, according to Art.8:1, paragraph (1), point 1, are not allowed to participate in the Game.

3. The course of the game

The Participant can attend the activities on (the platform) MyLogiscool (e.g. by completing a quiz or voting for Scoolcode projects), and can collect points there by their own during the Game. MyLogiscool keeps the Participant informed on the latest activities, appearing on the platform as new. Logiscool reserves the right to make additional gifts or prizes available during the Game for the benefit of the participants.

One Participant may be awarded one prize per draw. The lottery is done by using electronic lottery software. We do not announce additional winners during the game.

4. Prizes and guaranteed gifts

5. Notification of the winners and how they can receive their prize and the guaranteed gifts

We will contact the winners via the e-mail address of their legal representative in writing and inform them about the details how they can receive their prize and the guaranteed gifts. The winner is not entitled to receive the prize if:

- the legal representative does not respond to the notification message within 5 working days.
- for any reason, it is not possible to contact the winner's legal representative.
- the winner violates any point of these Game rules.

The Participants and their legal representatives are obliged to cooperate in receiving the prizes (in person or by mail). If they do not comply with this effort and they fail in receiving the prize, they will not be able to receive the prize after that and the Organizer is not responsible for this failure in any way. 6. Personal income tax

7. Rights and responsibilities of the Organizer

The Organizer *may suspend or cancel* the Game, if any kind of abuses or significant infringements or their suspect occur. The Organizer *is not responsible for and excludes* any compensation or reimbursement arising from the possible errors, shortcomings, malfunctions of the Game, or delays during the period of the Game and *excludes* the responsibility for the related costs, damages, losses including the responsibility of damages at the Participant, should it be caused intentionally or by obvious negligence. The Organizer *is not responsible* for the claims of the Participant or their legal representative if any of them may provide incorrect data (e.g. entering the wrong email address).

The Participants and their legal representatives *accept* the condition that they will fully compensate the Organizer for any damage caused to the Organizer by any violation of the Rules while participating in the Game.

8. Data management and data protection

Students (Scoolers) and their legal representatives provide their data at the registration to a Logiscool course voluntarily to the Organizer and agree the data management of their personal data by the Organizer. Therefore, the Organizer is entitled to manage Students (Scoolers)' data through their course registrations.

- The Organizer as data manager and data processor *manages* the data of the Participant and their legal representative, provided at the registration to Logiscool courses and during their length and at the current Game (name, place and time of birth, residential address, email address, mobile phone number). The Organizer deletes their data from the database after that.
- The name of the winner will be published in a post exclusively in connection with the Game, Scooler Mission.

The Organizer *guarantees* that data management is carried out in compliance with the applicable legal provisions. The Organizer *enables* the opportunity to the Participant and their legal representative any time for requesting information about the management of their personal data. Additionally, the Participant and their legal representative *have the right to object to* the processing of their personal data. The Participant may go to court, if they do not agree with the decision of the Organizer, based on their objection.
