

## Participation in Logiscool Course, Workshop and Camp General Terms and Conditions

The words and expressions hereunder shall mean the following in the Terms and Conditions:

- Logiscool Las Vegas SW School:** means the company with the underlined data:  
company name: New East West Coding LLC., dba. "Logiscool Las Vegas SW"  
registry number: 20222270429  
tax ID. number: 88-2021952  
legal representative: Bruce C. Bommarito
- Logiscool Kft.:** the company which is entitled to exclusively use Logiscool know-how with registry number 01-09-300066 and registered seat 1114 Budapest, Bartók Béla út 43-47., building C, floor 8.
- Course:** the non-school system course which is organized and executed by Logiscool Las Vegas SW School according to the Logiscool know-how.
- Camp:** the Logiscool Camp which is organized and executed by Logiscool Las Vegas SW School according to the Logiscool know-how. The Camp can be organized during the summer or in a sessional basis.
- Workshop:** the Logiscool Workshops are organized and executed by Logiscool Las Vegas SW School according to the Logiscool know-how.
- Student:** a child defined by Act V of 2013 (Civil Code) a minor aged 6 to 18, who participates in the Course or the Camp.
- Legal Representative:** the parent or legal guardian who practices the Student's parent control or the Student's bearer.
- Logiscool Year:** the period during which the Course is organized and executed September 2021-June 2022
- Contract:** a contract concluded in accordance with these Terms and Conditions between the Legal Representatives and Logiscool Las Vegas SW by which Logiscool Las Vegas SW School  
a) ensures the teaching in the selected Course, or  
b) organizes and executes the Camp,  
c) organizes and executes the Workshop,  
while the Legal Representative pays fee for the organization and execution of the Course, Workshop or the Camp as well as for the Student's chance to participate in the Course, Workshop or the Camp for Logiscool Las Vegas SW School.
- Price** the consideration defined by the Contract, and paid for the Logiscool Las Vegas SW School's services, which is named as Course Prize (in case of Course) or Participation Price (in case of a Camp).
- Schoolcode:** an electronically accessible teaching platform software made by Logiscool for the effective operation of Logiscool School which contains the curriculum, lesson notes and sample tasks (these are all parts of Logiscool know-how).

### Introduction

- A. The goal of **know-how „Logiscool Experience-Based Programming School”** designed by Logiscool is to summarize all those special organizational, mechanical, economical and teaching knowledge and methods that can help teach children aged 6 to 18 to programming and digital ability-training in a playful but organized way. Logiscool Schools have been set up and operating by the Logiscool know-how.

- B. Logiscool Las Vegas SW School undertakes to organize and execute Courses, Camps and Workshops to the Students, as well as assures other programs and services for the Students compliant to the regulations of the General Terms and Conditions by prize.

### **1. Announcement of the Courses, Camp and the Workshops**

- 1.1. The Logiscool Year's expected starting and finishing date, duration, program, the services provided during Logiscool Las Vegas SW School's courses, as well as their prize are announced in the [www.logiscool.com](http://www.logiscool.com) website. The Course is organized by Logiscool Las Vegas SW School with the consideration of the Course's place and local specialties. The services (namely the content and method of the education) provided in the Courses are equal in each Logiscool School. The location and connections of the Logiscool Las Vegas SW School are announced in the [www.logiscool.com](http://www.logiscool.com) website
- 1.2. The Camp's exact starting and finishing date, duration, program, the services provided during Logiscool Las Vegas SW School's Camp, as well as their prize are announced in the [www.logiscool.com](http://www.logiscool.com) website. The Camp is organized by the Logiscool Las Vegas SW School with the consideration of the Camp's place and local specialties. The educational services (namely the content and the method of the education) provided during the Camp are equal in each Logiscool Schools.
- 1.3. The Workshop's exact starting and finishing date, duration, program, the services provided during Logiscool Las Vegas SW School's Workshop, as well as their prize are announced in the [www.logiscool.com](http://www.logiscool.com) website. The Workshop is organized by the Logiscool Las Vegas SW School with the consideration of the Workshop's place and local specialties. The educational services (namely the content and the method of the education) provided during the Workshop are equal in each Logiscool Schools.

### **2. Establishment of the Contract**

- 2.1. The Contract for the participation in the Course or Workshop or the Camp is concluded between Logiscool Las Vegas SW School and the Legal Representative in electronic form.
- 2.2. It is exclusively possible to apply for the participation in the Course or Workshop or the Camp via the [www.logiscool.com](http://www.logiscool.com) website by filling the electronic Application Form about the Course or Workshop or the Camp.
- 2.3. During the filling of the Application Form, the Legal Representative of the Student less than 14 years old shall fill the Application Form instead of the Student, whereas the Legal Representative of the Student older than 14 years old with legal capacity shall fill the Application form with the Student. The filling by the Legal Representative of the Student less than 14 years old is considered as the Legal Representative's separate statement, while the filling by the Legal Representative of the Student older than 14 years old with legal capacity is considered as the Legal Representative's and the Student's common statement by the Logiscool Las Vegas SW School for the conclusion of the Contract. The Legal Representative is unconditionally responsible for the correctness and actuality of the given data – in case of Student older than 14 years old, he or she is unconditionally responsible in this aspect as well.
- 2.4. For the conclusion of the Contract the Legal Representative sends the filled Application form – as his or her own statement – to the Logiscool Las Vegas SW School in electronic form by clicking the "Send" button located in the Application form. By clicking the "Send" button, the Legal Representative accepts and understands that the sending of the Application form shall give rise to him or her a payment obligation, provided the Logiscool Las Vegas SW School confirms the application as defined in these Terms and Conditions. Prior sending the Application form, the Legal Representative shall read and accept the regulations of these Terms and Conditions, as well as Logiscool Kft.'s Privacy Policy by separately clicking the appropriate checkboxes. The content of the Application form can be checked and corrected prior sending.

### **2.5. Special contractual regulations concerning Courses**

- 2.5.1. It is only possible to register the Courses during the registration period opened in [logiscool.com](http://logiscool.com) website, until the 21th day after the starting day of the relevant Logiscool Semester.
- 2.5.2. After the sending of the Application form, Logiscool Las Vegas SW School sends a confirmation to the e-mail address pointed as the Legal Representative's e-mail address in the Application form, in which it

confirms that the Contract has been concluded between Logiscool Las Vegas SW School and the Legal Representative with the content of the Application form, however Logiscool Las Vegas SW School reserves the right to posteriorly, but no later than the starting day of the Course amend the terms – especially in connection with the days the Course is held, the Course's exact prize, and the use of preferences concerning the prizes – described in the confirmation e-mail.

- 2.5.3. The Contract is concluded between Logiscool Las Vegas SW School and the Legal Representative by sending the electronic confirmation e-mail described in point 2.5.2. according to the content of the Application form put in the confirmation and these Terms and Conditions.

## **2.6. Special contractual regulations concerning Workshops**

- 2.6.1. It is only possible to register the Workshop during the registration period opened in logiscool.com website.
- 2.6.2. After the sending of the Application form, Logiscool Las Vegas SW School sends a confirmation to the e-mail address pointed as the Legal Representative's e-mail address in the Application form, in which it confirms that the Contract has been concluded between Logiscool Las Vegas SW School and the Legal Representative with the content of the Application form, however Logiscool Las Vegas SW School reserves the right to posteriorly, but no later than the starting day of the Workshop amend the terms – especially in connection with the days the Workshop is held, the Workshop's exact prize, and the use of preferences concerning the prizes – described in the confirmation e-mail.
- 2.6.3. The Contract is concluded between Logiscool Las Vegas SW School and the Legal Representative by sending the electronic confirmation e-mail described in point 2.6.2. according to the content of the Application form put in the confirmation and these Terms and Conditions.

## **2.7. Special contractual regulations concerning Camps**

- 2.7.1. Having sent the Application form, Logiscool Las Vegas SW School sends an electronic message to the e-mail address pointed as the e-mail of the Student's Legal Representative in the Application Form, in which it confirms the content of the Application form and provides information about the sum of the prize's advancement as well as the banking data for the payment (asking for earnest money).
- 2.7.2. The Contract is concluded between Logiscool Las Vegas SW School and the Legal Representative by sending the electronic confirmation e-mail described in point 2.6.1. according to the content of the Application form put in the confirmation and these Terms and Conditions.

2.8. The Contract is qualified as a written contract. The primary language of the Contract is English. In condition that the Terms and Conditions are interpreted differently in other languages by the Parties, the English text is applicable at any case. The Contract can be found in Logiscool Kft.'s client database.

## **3. Processing personal data, use of personal images**

- 3.1. The Legal Representative – while filling the Application form – shall read and accept Logiscool's Privacy Policy. Logiscool Las Vegas SW School notifies the Legal Representative and the Student that by sending the Application form and accepting the Privacy Policy, the Legal Representative gives his or her consent for getting – based on the Student – personalized offers from Logiscool Las Vegas SW School and Logiscool to the e-mail address pointed in the Application form about participating in the Course or Workshop and the Camp.
- 3.2. The Logiscool Las Vegas SW School informs the Student and his or her Legal Representative that video-, picture-, or voice recordings of which a Student can be identified by (hereinafter referred to as: Recordings) may be made during the Course or Workshop and the Camp. The Recordings don't harm the Student's personality rights and human dignity. Logiscool Kft. and Logiscool Las Vegas SW School are exclusively entitled to use these Recordings. The goal of the Recordings is to introduce the Course's or Workshops's and Camps's atmosphere, the education as well as the Course's or Workshops's and Camps's results. The Records are primarily used for marketing purposes in the following areas: inserting in the [www.logiscool.com](http://www.logiscool.com) website, the official Youtube channel and social media

pages (such as Facebook, Instagram, Twitter) of Logiscool Kft. as well as in press, presentations and introductions. By filling the Application form and sending it to Logiscool Las Vegas SW School (see: point 2.4.), the Legal Representative and – if he or she is older than 14 years old – the Student give their consent for the use of the Records by the mentioned companies for the purposes and scope above, without time limitations. The Legal Representative and the Student are not entitled for any consideration for the use of Recordings. The Legal Representative and the Student older than 14 years old can anytime request not to use the Recordings made from the Student or to use them with restrictions or to erasure them by sending an electronic message to [datamanagement@logiscool.com](mailto:datamanagement@logiscool.com) e-mail address.

#### **4. The Prize**

##### **4.1. Special conditions of paying Course prize**

- 4.1.1. Despite the Course's prize is announced in [www.logiscool.com](http://www.logiscool.com) website, the regulations of the Contract concluded according to these Terms and Conditions are applicable in question of the Course's exact prize.
- 4.1.2. Logiscool Las Vegas SW School may make available preferences defined in Appendix 1 of these Terms and Conditions from the Course's prize. Logiscool Las Vegas SW School separately decide about which preferences and in what extent it makes available from Appendix 1 of the Terms and Conditions. Logiscool Las Vegas SW School may also make available preferences not defined in Appendix 1 of the Terms and Conditions too for the Student.
- 4.1.3. The Logiscool Las Vegas SW School observes the submitted electronic Application forms from the aspect of in what scope and extent can the preferences it uses be applicable in case of the Student and the selected Course defined in the Application form. Provided a preference is applicable, it – by pointing the relevant preferences and their measure – notifies the Legal Representative in an electronic message to the e-mail address given by the Legal Representative no later than the sending of the information defined in point 5 that the Course's prize is diminished by the applicable preferences. If the Legal Representative doesn't object in connection with the Course's prize 8 days after sending the electronic message, the Course's amended prize is deemed accepted by the Legal Representative. In case of objection, Logiscool Las Vegas SW School examines the objection and – if it is valid – observes the Course's prize according to the objection. Parties shall conciliate with each other in case of an invalid or partly invalid objection. In condition that the Parties don't make an arrangement on the Course's prize 8 days after the first day of conciliation, the Contract terminates on the ninth day after the first day of conciliation with any other regulation.
- 4.1.4. If the Terms and Conditions don't regulate otherwise, the Course's prize is determined for one Logiscool Year, which the Legal Representative pays during the Logiscool Year's calendar months in equal instalments (hereinafter referred to as: Prize instalment), with no regard to how many lessons were held in one calendar month. Provided the Course is partly held in a calendar month owing to the Logiscool Year's starting or finishing date (hereinafter referred to as: Part-month), Logiscool Las Vegas SW School notifies the Legal Representative via e-mail in the information defined in point 5 about the Prize Instalments exact measure in that specific calendar month. If the Student's application to the Course takes place within 21 days from the starting day of the Course, the Legal Representative shall pay the Course's prize from the starting day of the Course.
- 4.1.5. The Course's prize and the due Prize instalment shall be paid even if the Student is missing (for example because of sickness), since in such cases Logiscool Las Vegas SW School provides appropriate time for the substitution of the curriculum, of which detailed terms are sent to the Legal Representative via e-mail by the Logiscool Las Vegas SW School.
- 4.1.6. If the Terms and Conditions or the Contract doesn't regulate otherwise, the Prize instalments of the Course's prize during the Logiscool Year are due in each calendar month's eight day in advance. Logiscool Las Vegas SW School sends an invoice until each calendar month's first day about the due Prize instalment. Logiscool Las Vegas SW School is entitled to invoice the Part-month's Prize installment – fully or partly – with the following or the previous full-month's Prize instalment; in this case both Prize instalment is due eight days after making out the invoice.

## 4.2. Special conditions of paying Workshop prize

- 4.2.1. Despite the Workshop's prize is announced in [www.logiscool.com](http://www.logiscool.com) website, the regulations of the Contract concluded according to these Terms and Conditions are applicable in question of the Workshop's exact prize.
- 4.2.2. The Logiscool Las Vegas SW School observes the submitted electronic Application forms from the aspect of in what scope and extent can the preferences it uses be applicable in case of the Student and the selected Workshop or defined in the Application form. Provided a preference is applicable, it – by pointing the relevant preferences and their measure – notifies the Legal Representative in an electronic message to the e-mail address given by the Legal Representative no later than the sending of the information defined in point 5 that the Workshop's prize is diminished by the applicable preferences. If the Legal Representative doesn't object in connection with the Workshop's prize 8 days after sending the electronic message, the Workshop's amended prize is deemed accepted by the Legal Representative. In case of objection, Logiscool Las Vegas SW School examines the objection and – if it is valid – observes the Workshop's prize according to the objection. Parties shall conciliate with each other in case of an invalid or partly invalid objection. In condition that the Parties don't make an arrangement on the Workshop's prize 8 days after the first day of conciliation, the Contract terminates on the ninth day after the first day of conciliation with any other regulation.
- 4.2.3. If the Terms and Conditions or the Contract doesn't regulate otherwise, the Prize shall be paid in advance in one amount, or if the Logiscool Las Vegas SW School allows the fee can be paid in installments. Logiscool Las Vegas SW School sends an invoice before the start date of the Workshop. The prize is non refundable and missed classes will be forfeited and cannot be made up or refunded.

## 4.3. Special conditions of paying Participation prize

- 4.3.1. The Legal Representative pays the Participation prize in two instalments.
- 4.3.2. Participation prize in advance: sum, that is defined by Logiscool Las Vegas SW School and sent to the Legal Representative in the confirmation (see: point 2.6.), which shall not be more than 30% of the Participation prize. The advance prize is due eight days after the sending of the confirmation. Logiscool Las Vegas SW School – having the advance prize is entered on Logiscool Las Vegas SW School's bank account – posteriorly makes out an imprest account about the paid advance prize.
- 4.3.3. The full Participation prize not covered with the advance prize shall be paid eight days prior to the starting day of the Camp, of which Logiscool Las Vegas SW School makes out an invoice and sends to the Legal Representative.
- 4.4. Each prize payment shall be performed by transferring to the bank account written on the prepayment request or the invoice made out about the Prize or part of it. The Student's exact name and the prepayment request's or invoice's number shall be written down in the transfer's announcement part. If these announcements are not pointed out correctly, Logiscool Las Vegas SW School can't identify the payment and qualifies it as non-performed.
- 4.5. Each accounting document concerning the Prize is made out in electronic form. The prepayment request, invoice and other accounting document is sent in electronic form through the email address pointed as the Legal Representative's e-mail address on the Application form within the message's attachment to the Legal Representative.
- 4.6. It is Logiscool's interest to introduce the Logiscool method to as many children as possible. For this purpose, it contracts with third parties and partners in a way that the Prize – for the Student's interest, instead of the Legal Representative – is entirely or partly paid by these partners. To enable this, special promotional codes are handed out to the Student and to the Legal Representative. With the help of the promotional code, Logiscool can check whether the Student for whom the partner pays the Prize is effectively entitled to have resort for the payment.

Taking the services concerning promotion number is a separate data processing activity, of which legal basis is article 6 (1) point f) of the European Parliament and of the Council Regulation number 2016/679 (GDPR); Logiscool's and the Student's legitimate interest. It is Logiscool's interest to – through its partners – make preferred Students available the Course and the Camp. It is also the Student's legitimate interest to take the preference, to which it is sufficient to provide his or her personal data for this purpose. The data processing concerning promotion number is necessary for the performance of the goals defined above and doesn't restrict disproportionately the information self-determination rights of data subjects

In cases described in this point, Logiscool or Logiscool Las Vegas SW School separately inform the Legal Representative about the different paying conditions from the Terms and Conditions. It is notifiable that the regulations of the Terms and Conditions are applicable in cases when the part of the Prize is not paid by third party.

## **5. Informing about the Course or Workshop and the Camp**

- 5.1. Logiscool Las Vegas SW School informs the Student and the Legal Representative by sending an electronic letter to the Legal Representative's e-mail address before the starting day of the Course about pieces of information concerning the Course as well as any incidental change of the Contract's confirmed terms. Logiscool Las Vegas SW School registers the Students on the first day of the Course.
- 5.2. Logiscool Las Vegas SW School informs the Student and the Legal Representative by sending an electronic letter to the Legal Representative's e-mail address before the starting day of the Camp about pieces of information concerning the Camp. The informant's appendix is the so-called medical declaration. Logiscool Las Vegas SW School registers the Students on the first day of the Camp. During registration, the Student and the Legal Representative shall hand the Student's medical declaration – which was signed by the Legal Representative and the Student older than 14 years old – to the representative of Logiscool Las Vegas SW School.
6. During the time of the Course or Workshop or the Camp, the Student is under Logiscool Las Vegas SW School's control. The Legal Representative shall inform Logiscool Las Vegas SW School in the Application form about all the circumstances which are relevant to the secure monitoring of the Student, especially, but not exclusively, if the Student:
  - (a) regularly takes medicine, or the taking of the medicine should be inspected;
  - (b) is allergic to a medicine, food, or other substance;
  - (c) shall not do or practice specific activities for some reason;
  - (d) is sensitive to food or beverage;
  - (e) has behavioral issues owing to psychical or organic causes;
  - (f) can't take part in some of the Course's or Workshop's or the Camp's events or programs for some reason.

The Legal Representative is liable for all the damages or disadvantages that are caused by missing to give information about these circumstances.

Logiscool Las Vegas SW School – for the performance of the Contract – preserves the above mentioned data 30 days after the end of the Course, Workshop and the Camp.

7. During the Course, Workshop and the Camp, Logiscool Las Vegas SW School and its employees representing them are making all the measures and actions that are expected from them for the safe and lawful execution of the Course, Workshop and the Camp. Logiscool Las Vegas SW School and its teachers, camp leaders, animators representing them are making everything that is expected from them for the organization and execution of the Course, Workshop and the Camp in a high standard, as well as for the teaching- and free-time programs' execution in a high standard.

## **8. Rules concerning holding the Course's and Workshop's lessons and participating in them**

- 8.1. The Course's and Workshop's lessons are usually held in weekdays and Saturdays in the dates announced on logiscool.com. If the Legal Representative disposes that way, the Student older than 12 years old may leave the Course's and Workshop's lesson on his or her own after the end of the lesson. In other cases, the Student can only be taken away after the end of the Course's or Workshop's lesson by his or her Legal Representative, or by an adult person with legal capacity who was pointed in the Application form. In the second case Logiscool Las Vegas SW School – for the protection of the Student – may check the identity of the person who takes away the Student by observing this person's identity card and matching it with the data from the Application form.
- 8.2. If the Student misses from one of the Course's lessons for some reason, Logiscool Las Vegas SW School provides a substitution for the missed lesson's curriculum; the conditions of these are shared in the information described in point 5. Logiscool Las Vegas SW School's leader/coordinator shall always conciliate with the Legal Representative about the substitution. Logiscool Las Vegas SW School shall provide no more than three occasions for substitution in one semester.
- 8.3. It is not possible to maintain valuable objects or cash in the Courses and Workshops, so that Logiscool Las Vegas SW School is not liable for the security of those.

- 8.4. Student and the Legal Representative accepts that the Student is participating in the Courses and Workshop on his or her own liability.
- 8.5. Both the Student and the Legal Representative shall be abide by the regulations of Logiscool Las Vegas SW School's policy during the Courses and Workshops. The policy is available in a way that is described in the electronic message from point 5.

## **9. Rules concerning holding the Camp and participating in them**

- 9.1. Logiscool Las Vegas SW School announces the Camp's exact daily starting and finishing dates on logiscool.com and notifies the Legal Representative about it in the informative described in point 5. If the Legal Representative disposes that way, the Student older than 12 years old may leave the Camp on his or her own in the end of the Camp's daily time. In other cases, the Student can only be taken away from the Camp by his or her Legal Representative, or by an adult person with legal capacity who was pointed in the Application form. In the second case Logiscool Las Vegas SW School – for the protection of the Student – may check the identity of the person who takes away the Student by observing this person's identity card and matching it with the data from the Application form.
- 9.2. It is not possible to maintain valuable objects or cash in the Camp, so that Logiscool Las Vegas SW School is not liable for the security of those.
- 9.3. Student and the Legal Representative accepts that the Student is participating in the Camp's sport- and other programs on his or her own liability.
- 9.4. Both the Student and the Legal Representative shall be abide by the regulations of the Camp's policy during the camping. The policy is available in a way that is described in the electronic message from point 5.

## **10. Logiscool Online Terms and Conditions**

The purpose of these Terms and Conditions is the protection of students and to maximize the productivity and positivity of Logiscool Online programs (courses, workshops and camps). By purchasing, using, or allowing your student to use any form of Logiscool Online Education, you agree that you and your student will fully comply with Terms and Conditions.

### **10.1 Rules of behaviour**

I agree that I have read through and reviewed the Rules of behaviour with my student. I understand and agree that my student and I will comply with these Rules of behaviour as set forth below. I understand that my student and I must behave and act in a way that are fully in line with the Rules of behaviour and that my student's Logiscool Online Education program can be cancelled if either of our actions or attitudes seem to be significantly disrupting the education, other participants, or staff, in the opinion of Logiscool staff. I and my student understand that Logiscool reserves the right to cancel my student's Logiscool Online Education program without any prior warning for violating any of the terms of the Rules of behaviour. **Refunds will not be given for programs cancelled for failure of the student or the parent to comply with the Rules of behaviour.** I also acknowledge that upon staff observation of my student, they may determine that the Logiscool Online Education is not a suitable and/or productive environment for my student. In this case, Logiscool may cancel all remaining elements of the program and no refund will be issued. Logiscool makes great efforts to achieve excellent relationships with students. However, in some rare cases, Logiscool Online Education programs may not be a suitable environment for every student.

#### **Students and Parents/Guardians May NEVER:**

1. bully, intimidate, or harass others.
2. sexually harass others.
3. engage in or threaten violence.
4. impersonate another person.
5. use inappropriate language.
6. use this service, or materials provided as part of this service for illegal or immoral activity.
7. display pornography or any inappropriate material (including sexual content, inappropriate violence, racism, bullying, etc.) during lessons; or personally, contact trainers outside of lessons.
8. share lesson information with third parties, without permission of Logiscool.
9. publicly display lesson(s).

#### **Students and Parents/Guardians MUST:**

## **10.2 Logiscool Online Programs**

### **10.2.1 Live Online Classes**

1. Classes are set on Logiscool website (fixed start dates, day of the week, and time) by registering to the course on <https://www.logiscool.com/en/>.
2. Each class runs for 90 minutes and will have no more than 8 participants in each class.
3. The fee and payment method for Group Classes are communicated on Logiscool webpage <https://www.logiscool.com/en/> the price is non-refundable and missed classes will be forfeited and cannot be made up or refunded.
4. Only students registered for the class may participate.
5. Classes are only available for subjects set out by Logiscool
6. For safety and security reasons, Logiscool will video record every class. In case of the Rules of behaviour was breached parents and guardians can obtain a copy of the recording if by sending an email request to [hello.lasvegas.sw@logiscool.com](mailto:hello.lasvegas.sw@logiscool.com). Logiscool has the right to refuse service.

## **10.3 Contacting Trainers**

Students and parents/guardians should be aware that under no circumstances should students give their personal contact information to trainers, nor are trainers allowed to give students or parents/guardians their personal contact information. Other than during the lessons, trainers are not permitted to communicate privately with, give out personal contact info to, or become social media friends with students.

## **11.Schoolcode**

If necessary for the education, Logiscool Kft. – for the successful fulfillment of the Course or Workshop and the Camp – makes some of Schoolcode's part available for the Student. Registration is needed for the access. The user name and the password for the registration is provided by Logiscool Kft. for the Student. Both the Legal Representative and the Student with restricted legal capacity shall accept the Schoolcode Terms of Use by clicking during the registration.

## **12. Duration and resignation of the Contract**

12.1. The Contract concluded according to the Terms and Conditions – if the Contract doesn't terminate earlier – is effective until the day before the following Logiscool Year's first day in case of the Course, and until the thirtieth day after the Camping's finishing date in case of Camping. Despite the termination of the Contract, some specific rights and obligations – because of their character – can be practiced and performed after the termination of the Contract in the following (such as: use of Recordings, offers, sending newsletter). The Logiscool Year's starting and finishing date can't be amended so that the Legal Representative can't request the Logiscool Las Vegas SW School to provide its services before the start of the Logiscool Year's starting day.

12.2. Logiscool Las Vegas SW School is entitled to immediately resign the Contract, if the Student:

- (a) breaches the Course's, Workshop's and the Camp's order multiply times;
- (b) severely breaches the Course's, Workshop's and the Camp's order;
- (c) deliberate injury;
- (d) coerce, threaten or hurt other Student.

In case of immediate resignation, the Legal Representative shall immediately take the Student away from the Course's, Workshop's lesson or the Camp. In case of immediate resignation, Logiscool Las Vegas SW School is not obliged to refund the already paid full- or part- prize

## **12.3. Special regulations of the termination of Course-subject Contracts**

12.3.1. The Contract – in case of Course or Workshop – terminates in the relevant calendar month's last day without any other regulation or statement, provided any due Course or Workshop prize is not paid until the calendar month's last day determined in the invoice or the payment is not qualified as completed according to the Terms and Conditions.



12.3.2. The Legal Representative may – without justification – resign the Contract in written form during the Logiscool Year for the last day of one of the Logiscool Year's calendar month, in which case the Contract terminates on the last day of the calendar month the resignation is announced. Logiscool School is entitled for the Course prize of the calendar month the resignation is announced, it is not obliged to refund it, apart from the fact that the Student had participated in all or some part of the calendar month's lessons the resignation is announced. If more month's Course Prize is paid in lump sum in advance, the Course Prize(es) for the months after the resignation's calendar month shall be paid back.

12.3.3. The Logiscool Las Vegas SW School is entitled to resign the Contract, if the organization of a given Course or Workshop is – because of an unexpected cause – is frustrated. In this case, Logiscool Las Vegas SW School shall exclusively refund the already paid Course or Workshop prizes, it is not bound to perform other payments on any titles.

#### **12.4. Special regulations of the termination of Camp-subject Contracts**

12.4.1. The Legal Representative is – with paying earnest money – entitled to resign the Contract without justification in the following terms:

- (a) if the resignation happens until the 10<sup>th</sup> day before the Camp's starting day, the earnest money's sum is 11 % of the Participation prize;
- (b) if the resignation happens 10 days before the Camp's starting day, the earnest money's sum is 22 % of the Participation prize.

12.4.2. The Legal Representative – in a certified and an especially reasonable case (such a certified health issue) – is entitled to resign the Contract and take the Student away from the Camp, in which case he or she can lay claim for the refund of the Camp prize's part that is in proportion with the time left from the Camp in the time of the Student's leave and the Camp's full duration.

12.4.3. The Logiscool Las Vegas SW School is entitled to resign the Contract, if the organization of a given Camp is – because of an unexpected cause – is frustrated. In this case, Logiscool Las Vegas SW School shall exclusively refund the already paid Camp prizes, it is not bound to perform other payments on any titles.

12.4.4. The Contract – in case of Camp – terminates in the first working day after the time of expiration without any other regulation or statement, provided the Participation prize or the Participation prize's part not covered with the advancement is not paid until the deadline determined in the invoice/prepayment request or the payment is not qualified as completed according to the Terms and Conditions.

12.5. In condition that Logiscool Las Vegas SW School is obliged to refund the Prize partly or entirely, it pays it by transferring to the bank account of which the paying of the Course or Workshop prize to Logiscool Las Vegas SW School had been transferred. Logiscool Las Vegas SW School may count in its possible claims to the refund prize.

### **13. Injuries, indemnification**

13.1. The Student's Legal Representative – by sending the Application form to Logiscool Las Vegas SW School (see: point 2.4.) – accepts and undertakes that he or she – in the name of and instead of the Student, – compensates all the injuries arising from the Student's defaulting of unlawful behavior for the injured during the participation of the Course (both on and off the lessons), or Workshop, or the Camp, apart from the fact that the Legal Representative is obliged to indemnify for the injuries by law or not. The Legal Representative may entirely or partly be exempt from indemnification, if he or she certifies that the damaging behavior is owing to the attributable behavior or the failure of Logiscool Las Vegas SW School in connection with the Student's monitoring. The Legal Representative's indemnification covers all the damages appeared on the side of Logiscool Las Vegas SW School, other Student, or any other third person.

13.2. In case of the Student's damaging behavior – if the damage's circumstances allow it – Logiscool Las Vegas SW School notifies the Legal Representative as soon as possible. Logiscool Las Vegas SW School – if the damage's circumstances allow it – reports the harmful event, which can be signed by the Legal Representative.

13.3. Logiscool Las Vegas SW School is exclusively responsible for the diligence organization and execution of the Course, the Workshop, and the Camp, as well as the thoughtful monitoring of the Students with regard to the laws, the Terms and Conditions, and the regulations of the Contract. In conformity with this, it is liable for those damages that directly arise from the intentional or negligent breach of the applicable law, the Terms and Conditions, and any regulation of the Contract, or the intentional or negligent ignorance of the Application form's content or data or behaving contrary to those. In condition that Logiscool Las Vegas SW School is obliged to indemnify the damages for a certain behavior, it shall exclusively indemnify the direct damages to property, so that it can't be compelled to pay foregone benefit or detriment prize.

#### **14. Statements**

14.1. Logiscool Las Vegas SW School shares its statements in a confirmed electronic message concerning the performance of the Contract with the Legal Representative and the Student – if the Terms and Conditions doesn't regulate otherwise – from the [www.logiscool.com](http://www.logiscool.com) website's Logiscool Las Vegas SW School's e-mail address to the e-mail address that was written down by the Legal Representative in the Application form.

14.2. The Legal Representative shall send his or her statements concerning the Contract – if the Terms and Conditions don't regulate otherwise – to the e-mail address placed on the Logiscool Las Vegas SW School's website in [www.logiscool.com](http://www.logiscool.com) from the e-mail address pointed in the Application form via an electronic message with a delivery confirmation.

14.3. Parties accept that the electronic message contains the written statement of Logiscool Las Vegas SW School, the Legal Representative and the Student older than 14 years old, if it meets the requirements described in point 13.1. and 13.2.

#### **15. Scope and publication of the Terms and Conditions**

15.1. The regulations of the Terms and Conditions are effective as of the 10<sup>th</sup> of June 2022, and applicable to the Contracts concluded from that date.

15.2. Logiscool Las Vegas SW School notifies the Legal Representative about the possible amendment of the Terms and Conditions 15 days before the entry into force.

## **Appendix number 1**

**Logiscool Las Vegas SW School determines the following preferences:**

- (a) Own student preference
- (b) Group preference
- (c) Sibling preference
- (d) Lump-sum payment preference
- (e) Special preferences

**The extend of the preferences used by Logiscool Las Vegas SW School is listed in [www.logiscool.com](http://www.logiscool.com) website's Logiscool Las Vegas SW School page.**

### **1. Own Student preference**

- 1.1. The Student is entitled to take Own Student preference, if he or she
  - i) had been the Student of the Logiscool Las Vegas SW School in more semesters in line, or
  - ii) had been the Student of Logiscool Las Vegas SW School at least in one semester and – directly after or before the semester – participated in the summer camp organized by Logiscool Las Vegas SW School as well straight before registering to a specific Course in the Logiscool Year.
- 1.2. The extend of the preferences depends on the semester in lines' and camps' number and combination in the following way.  
There can be one summer camp considered during the calculation of the preferences.  
The Student is entitled to take a gradually ascending preference, if he or she
  - i) had been the Student of Logiscool Las Vegas SW School in two semesters in line, or one semester and a summer camp, or three semesters in line, or two semesters in line and a summer camp,
  - ii) had been the Student of Logiscool Las Vegas SW School in four semesters in line, or three semesters in line and a summer campstraight before registering to a specific Course in the Logiscool Year or to a Camp.

### **2. Group preference**

- 2.1. The Student is entitled to take Group preference, if he or she registers to a specific Course of Logiscool Year or Camp for the first time in Logiscool Las Vegas SW School together with at least three other Students registering to the Course's Logiscool Year or Camp for the first time as well and they each give the same group name invented by them during the registration to Logiscool Las Vegas SW School.
- 2.2. Students pointed in a given group can only take the preference in the first Logiscool Year. After the preferential Logiscool Year is passed, the Student who applies again to one of the Courses – provided the conditions are met – may take Own Student Preference.
- 2.3. In condition that one of the Students doesn't intend to attend in the Course during the preferential Logiscool Year in the following, the preferences taken by this Student and the other Students are not affected by that.

### **3. Sibling preference**

- 3.1. The Student is entitled for Siblings preference in the Logiscool Year, if his or her sibling is registered to the same Logiscool Year and Logiscool Las Vegas SW School. The sibling's name must be given during the registration to Logiscool Las Vegas SW School.
- 3.2. Siblings are Students who are keeping house together with each other by their permanent address registered on their address card.
- 3.3. All the siblings are entitled for Sibling preference until the end of the relevant school year.

#### **4. Lump-sum payment preference**

If the Course's entire prize for the Logiscool Year or one of the Logiscool Semesters is paid in lump-sum, the Course's prize can be decreased by Logiscool Las Vegas SW School with preference.

#### **5. Other, special preferences**

- 5.1. Logiscool Las Vegas SW School may announce other, special preferences for Students in the scope determined hereunder. In this case, the preference's exact conditions are announced in the Logiscool school's website or the specific Logiscool school's Facebook site.
- 5.2. Special preference can be, for example:
  - i) Scholarship preference – preference that can be taken by the given Logiscool school's prize alignment;
  - ii) Preferences concerning promotional codes (specifically: early applicant preference, discount preference, company cooperation, event/race winner's preference)

The Special preference's extent may be 5 percent to 100 percent.

#### **6. Aggregating preferences**

- 6.1. Sibling preference can be aggregated with Own Student preference and Group preference, although the preference's complete extent shall not exceed 15 percent of the Course's prize, except Sibling preference.
- 6.2. Lump-sum payment preference can be aggregated with any other special preferences.
